Description:

This is a section of a small ground stone object, the function of which is unexplained. If it were larger and made of a more common material, then it would undoubtedly be considered as a handstone or "mano" section. It is much smaller than most of these artifacts, however, and is made of a very fine grained material in some respects like sandstone. Its density is more reminiscent of a metamorphosed material, though. It is quite definitely silicaceous but apparently does not fracture concoidally although the fractures present on this specimen may not be representative of the density of the material. They could represent breaks along flaws in the material. It is certainly not an ordinary handstone in any case. Its bright red color is reminiscent of the color of much of the hematite in the debris.

# Historic Ceramic Artifacts

Glass Beads

Plate XX, Nos. 13, 14

Number of Specimens: 2

Description:

Two glass beads were found at the site, one in Level 2 of the deep squares and one in Level 2 of the O-S1O area. One of the beads is complete and the other represents one half of a bead. The whole specimen is made of clear glass and is of simple construction. It is a globular bead with the ends cut off. There are six full facets around its diameter and parts of six others both above and below the complete facets. Such a bead, with the ends present, would probably

have 20 facets. The second bead is one-half of a round red bead of simple construction.

#### East or Davis Incised

Number of Specimens: 1

Original Type Definition and Description: Suhm, Krieger and Jelks 1954.

Description:

This may be a sherd of an East or Davis Incised vessel. It is a rim sherd with three incised lines apparently encircling the vessel parallel to the rim and about 1/2 inch apart. There may have been more of these lines involved in the whole pattern. Its temper is coarse and abundant clay/grit which is apparently more characteristic of Davis Incised than of East Incised. The difference is not viewed as being highly significant in any case since both types direct attention to the very early stages of the Caddoan sequence. The form represented is probably a straight sided bowl. The rim is vertical and flat. It has been only roughly smoothed. It is brown throughout.

One of these sherds is tempered with sand and clay, is black and has four parallel lines incised into its face. Two others are rim sherds, tempered


